Teaser	<p>If you wish to use the protected professional title "Consulting Engineer", you must be registered with the Chamber of Engineers. You can apply for this, provided that you meet the applicable requirements.</p>
Volltext	<p>The Chamber of Engineers Thuringia as a public corporation has the central task, in addition to safeguarding the professional interests of engineers and the reputation of the profession, at the same time to monitor the fulfillment of professional obligations.</p> <p>Compulsory members of the Thuringian Chamber of Engineers are engineers who are registered in the list of engineers authorized to submit building documents as well as engineers who are registered in the list of consulting engineers (§ 21 para. 3 ThürAIKG).</p> <p>Only those who are registered in the list of consulting engineers may use the legally protected professional title "Consulting Engineer".</p> <p>The registration also documents that the registered person has the professional qualification and independence required by law and is subject to the professional law of consulting engineers as well as the control by the Chamber of Engineers of Thuringia. Thus, there is a special protection of the professional title consulting engineer, which goes beyond the given protection standards of the professional title engineer.</p>
Erforderliche Unterlagen	As a rule, the following documents are required:

- Fully completed application documents including Annex 1 (technical sheet for the application for registration in the list of consulting engineers)
- Copy of identity card/passport
- Proof of education including a copy of the education certificate (diploma, Bachelor's/Master's degree certificate, etc.)
- Registration certificate concerning the main residence or proof of a professional domicile or the exercise of the predominant professional activity in Thuringia
- Official certificate of good conduct
- proof of sufficient professional liability insurance
- If necessary, the Thuringian Chamber of Engineers may require the submission of further proof, if necessary also as a certified copy.

## Voraussetzungen

In order to be registered in the list of consulting engineers kept by the Chamber of Engineers of Thuringia and in order to establish a compulsory membership at the same time, special factual requirements have to be met, in particular professional qualifications proven by a corresponding engineering degree as well as proof of practical experience.

An entry in the list of consulting engineers, which requires the presentation of an application, is to be made if the following requirements are met:

1. The applicant must have his main residence, a professional branch or the place of predominant professional activity in Thuringia (§ 8 para. 2 no. 1 ThürAIKG).
2. The applicant must be entitled to use the professional title "engineer" as defined in Section 4 (1) ThürAIKG.
3. After the acquisition of the authorization to use the professional title "engineer", he must have exercised at least two years of full-time practical activity in the essential professional tasks in the field of engineering

and thus a corresponding professional practice.

4. In order to be entered in the list of consulting engineers, the applicant must exercise his professional tasks autonomously and independently at the time of application.

The requirements to be fulfilled for this are specifically set out in § 3 para. 2 ThürAIKG. According to this, engineers are considered to be working independently if they run their own engineering office, have joined forces with other members of the liberal professions and have a legal status within this association by virtue of which they can perform their professional duties uninfluenced by rights of third parties outside the profession within the association or by rights of third parties outside the association.

Independently active persons are those who, in the course of their professional activities, neither pursue their own production, trade, supply or comparable economic interests, nor represent third-party interests of this kind which are directly or indirectly connected with the professional activity.

5. In addition, the applicants must have the reliability or suitability required for the profession of consulting engineer, otherwise a refusal according to § 12 para. 1, 2 ThürAIKG may be considered if there are relevant legally binding criminal convictions, lack of legal capacity or financially disorderly circumstances.

The registration committee of the Thuringian Chamber of Engineers decides on the requested registration in the list of consulting engineers.

Anyone who uses the professional title of consulting engineer without authorization can be fined up to €

30,000 by way of administrative offense proceedings to be initiated by the Thuringian Chamber of Engineers.

Foreign service providers who are nationals of a member state of the EU or a state equivalent to these may use the professional title of consulting engineer if they have proven to the Chamber of Engineers in accordance with § 14 Para. 6 ThürAIKG that they meet the requirements and are subsequently entered in the register of foreign service providers.

## Kosten

For the processing of the application for membership and registration in the list of consulting engineers, the application fee is in principle € 350.00.

The legal basis for charging the fee is the cost regulation of the Chamber of Engineers Thuringia from 26.10.2017.

## Verfahrensablauf

After the application has been submitted, the Thuringian Chamber of Engineers will confirm receipt of the application, including the submitted evidence, to the applicant within one month and, if applicable, inform the applicant of any evidence that is still missing.

A decision on the application will be made within three months of receipt of the complete supporting documents at the latest, although this period may be extended by a further month.

As a result of the examination to be carried out by the registration committee of the Thuringian Chamber of Engineers regarding the existence of the legal requirements, the person submitting the application

will be notified accordingly. The decision made therein constitutes an administrative act.

The documents submitted by the applicant with the application remain with the Chamber of Engineers Thuringia and are archived there.

**Bearbeitungsdauer**
**Frist**

There are no deadlines to be observed. Rather, the decisive factor for submitting an application is the applicant's own interest.

**Hinweise**

The professional title "Consulting Engineer" may only be used by those who are registered in the list of "Consulting Engineers" maintained by the Chamber of Engineers. The basic prerequisite for registration is independence and personal responsibility. Registration in the corresponding list establishes membership in the pension fund.

**Rechtsbehelf**

An action against a decision of the Chamber of Engineers of Thuringia can be brought before the administrative court responsible for the place of residence of the applicant within one month of receipt of the decision, in writing or for recording by the clerk of the administrative court.

Preliminary proceedings or opposition proceedings do not take place.

**Kurztext**
