Teaser	There is a legal obligation to report the use of plant protection products for other persons, businesses and companies. If you wish to carry out this activity in Thuringia, notify the competent authority here.
Volltext	<p>There is a duty of notification for the application of plant protection products for other persons, businesses and companies. This does not apply to occasional, non-regular neighborly assistance or one-time substitution in case of illness.</p> <p>The place of business and the place(s) of activity may be located in different federal states. Therefore, the notification has to be made separately at the respective local authority before starting the activity. Notifiable activities in Thuringia must be reported to the Thuringian State Office for Agriculture and Rural Areas (TLLLR).</p> <p>The obligation to notify the use of plant protection products in service concerns e.g. agricultural contractors but also service providers in the field of horticulture (home garden or indoor greening care, janitor service).</p>

Sachverhalt

The application of plant protection products for others may only be carried out by qualified persons who have the necessary reliability as well as the required technical knowledge and skills and have proven these to the authorities. Changes in the group of persons and those affecting the operating details as well as the termination of the notifiable activity must also be reported immediately.

If all requirements and information are fulfilled, the official registration as a service-providing user of plant protection products within the meaning of Section 10 of the Plant Protection Act in Thuringia takes place.

Erforderliche Unterlagen

- truthfully and completely filled in notification form including the private addresses of the persons applying the product
- a copy on both sides of the plant protection certificate for the application/consulting (card) of all persons who carry out an application in accordance with § 10 PflSchG in Thuringia

Voraussetzungen

Prerequisite for the application of plant protection products for others is mandatory the possession of the certificate of expertise in plant protection (card) for users/consultants. In addition to this, state-approved training events must be attended regularly. A service-providing user of plant protection products must accordingly be knowledgeable.

Kosten

Initial notification 15.00 EUR, change notification 7.00 EUR

Verfahrensablauf

Upon receipt of the notification the Office checks the completeness, the factual correctness of the information and whether the requirements for registration as a service user of plant protection products are met. If there are any queries or additional requirements, you will be contacted. If all requirements and information are fulfilled, the official registration will take place. You will receive a notification of this. You will be assigned a registration number which must be used for future notifications of changes. In addition, the notification lists the registered areas of activity and all persons registered for these areas by name. Since this is a chargeable public service, you will also receive

	<p>a cost notification.</p> <p>If you discontinue the notifiable activity, it is sufficient to send an informal message to the e-mail address below to deregister the use of plant protection products for others, stating your registration number and the date of discontinuation of notifiable activities.</p> <p>Your information will be checked systematically and on an ad hoc basis as part of plant protection inspections.</p>
Bearbeitungsdauer	Up to 2 weeks if the complete documents are available.
Frist	The initial notification must be made before the start of the activity. Any changes to the legally required information must be reported immediately and on an ongoing basis. If additional information or documents are required in the course of your notification, deadlines may also be set for this purpose.

Hinweise	<p>Persons who apply plant protection products for others are controlled for compliance with the legal regulations in plant protection. Rechtsbehelf	You can lodge an objection against this administrative act with the Thuringian State Office for Agriculture and Rural Areas based in Jena within one month of notification. The deadline is also met by timely receipt at a branch office of the State Office.
