Volltext	If you operate as a showman, "flying trader" or owner of a market stall, i.e. if you offer your services or goods at constantly changing locations, you are operating a travel trade. For this purpose, you need a travel trade card. You can change or add to the activities listed in the travel trade card at the competent authority .
Erforderliche Unterlagen	• Identity card or passport • Travel trade card • If applicable, extract from the register of companies, associations or cooperatives • If applicable, certificate of good conduct/extract from the central commercial register • If applicable, trade card • Proof of showman's liability insurance, if applicable
Voraussetzungen	You must already be in possession of a travel business card.
Kosten	Fees are charged in accordance with the state's fee ordinance.

Verfahrensablauf	You can apply to your municipality or city administration for the subsequent inclusion, amendment and addition of conditions to your travel business card. To do this, contact the municipality or city administration in which you have your usual place of residence or in which the future business will have its registered office.
Bearbeitungsdauer	The processing time is approximately 1 - 3 weeks, if all documents are complete.
