Teaser	You need a travel trade card for a travel trade. You can have a temporary travel trade card extended by the competent authority.
Volltext	If you operate as a showman, "flying trader" or owner of a market stall, i.e. if you offer your services or goods at constantly changing locations, you are operating a travel trade. For this purpose, you need a travel trade card. The content of the travel trade permit may be restricted, it may be issued for a limited period of time and it may be subject to conditions, insofar as this is necessary for the protection of the general public or consumers. If you have a temporary travel business card, you can renew it at the competent authority.
Erforderliche Unterlagen	• Identity card or passport • Travel trade card • If applicable, extract from the register of companies, associations or cooperatives • If applicable, certificate of good conduct/extract from the central commercial register • If applicable, trade card • Proof of showman's liability insurance, if applicable
Voraussetzungen	You must already be in possession of a travel business card.
Kosten	Fee in accordance with the cost regulations of the responsible state/authority.
