Volltext	If you wish to provide debt collection services on a business basis, you must register this activity in the Legal Services Register. You can be registered if you are personally suitable and reliable for carrying out the activity and also have special expertise and can prove this accordingly. Important criteria for the required reliability are • previous criminal record (in particular any criminal offences) and • the economic circumstances. Registration may be made subject to conditions or associated with requirements. Conditions can be imposed or changed at any time. Legal services that are ancillary to another activity (e.g. collection of customer claims that have been assigned to a garage on account of performance) are not subject to authorization. Registration in the legal services register is not required for these services.
Erforderliche Unterlagen	In particular, the following must be submitted with the application • a summary of the professional training course and the previous professional practice • Certificate of good conduct

- Declaration as to whether insolvency proceedings are pending or whether an entry has been made in the debtors' register within the last three years prior to the application being submitted
- Declaration as to whether registration or admission to the bar has been refused, withdrawn or revoked in the last three years or whether there has been an exclusion from the bar, if applicable a copy of the decision
- Documents proving theoretical and practical expertise (e.g. certificates)
- Proof of professional liability insurance
