Volltext	The coat of arms of a municipality, city or county may be used only with the permission of the municipality concerned.

Verfahrensablauf	Apply for the use of the coat of arms to the administration of the municipality whose coat of arms you wish to use. The municipality will decide on the application and notify you of the decision. The details of the procedure are determined by the municipality within the framework of the law.

Hinweise	Even a modified or stylized coat of arms that may be confused with the coat of arms of a municipality may be used only with the permission of the municipality concerned. Municipalities may regulate the use, including the approval, of coats of arms by a statute. In the statute,
