Verfahrensablauf	You can apply for benefits for education and participation. If possible, find out in advance from the relevant office how to apply for benefits from the education package most easily. The staff will also help you with the application if you wish. Fill out the required forms, sign the application and gather the necessary evidence. Send the complete application documents by mail to the responsible office or hand them in personally. You will receive written notification as to whether your child is eligible for the program and, if so, which program(s).
