Upon application, the parental contribution for parents with low income or receiving social benefits for the attendance of the child/children in a kindergarten or child day care will be paid in full or in part by the Youth Welfare Office, if the burden is not reasonable for the parents and the child.

Sachverhalt

- Benefits of the economic youth welfare:
- Full or partial assumption or reimbursement of parental fees in kindergartens or day care centers.
- Prerequisite:
- Application
- Economically unable to pay
- Economic capability is always present in any case in the following cases:
 - Benefits according to SGB II (citizen's allowance or benefits according to the education and participation package)
 - Benefits according to §§ 2,3 of the Asylum Seekers Benefits Act (Asylbewerberleistungsgesetz)
 - Benefits according to the third and fourth chapters of SGB XII
 - Receipt of child benefit supplement according to § 6a of the Federal Child Benefit Act (Bundeskindergeldgesetz)
 - Receipt of housing allowance according to the housing allowance law
