Volltext	If you intend to start operating an energy supply network, you must apply for a corresponding permit.
Erforderliche Unterlagen	• Presentation of the company • Proof of the legal form of the company (extract from the commercial register, articles of association) • Information on the network (presentation of the network, network capacity, pressure levels or voltage levels, connection customers and their structure) • Documents on personnel and technical capacity • Organizational chart with number of employees and their qualifications, technical equipment (see VDN guideline S 1000 or DVGW worksheet G 1000), submission of contracts with subcontractors • Documents on economic performance (proof of equity capital, shareholdings in the company, most recent profit and loss account, annual report) • If a network is established or acquired: submission of a profit and loss account (investments and depreciation, capital and financial plan, operating expenses, profit and loss account)
Voraussetzungen	You have the • efficiency in personnel, technical and economic terms and • reliability, to ensure the long-term operation of the grid in accordance with the provisions of the Energy Industry Act.
Kosten	The envisaged fee range is between 150 and 2,000 euros.
