This applies to the following activities, for example: • Activities on refrigeration systems, air conditioning systems and heat pumps, • work on equipment containing fluorinated greenhouse gases as solvents, • Work on fire protection systems and fire extinguishers, • activities on high-voltage switchgear and • work on air conditioning systems in motor vehicles. In order to obtain a certificate of competence, you must pass a theoretical and practical examination.
