Erforderliche Unterlagen	• Application form • Photograph • Proof that the reasons that were decisive for the revocation of the order no longer exist • Provisional confirmation of cover in response to the application to take out professional indemnity insurance
Voraussetzungen	In addition to passing the tax consultant examination or aptitude test (or the exemption from the tax consultant examination), your personal suitability will determine whether you will be reappointed for the job. The Chamber of Tax Advisors to which you belonged at the time of expiry or revocation of the appointment will also be involved in the reappointment procedure. You can be reappointed as a tax advisor if: • the appointment has expired by waiver vis-à-vis the competent Chamber of Tax Consultants, • a final exclusion from the profession has been lifted by a pardon or at least eight years have elapsed since the final exclusion, or • the order has been revoked and the reasons that were decisive for the revocation no longer exist.

Kosten	Gebühr: 150€ For the procedure The costs for the procedure are 150.00 euros. In addition, members are obliged to pay a chamber fee.
Verfahrensablauf	You must apply for reappointment in writing to the Rhineland-Palatinate Chamber of Tax Advisors using the officially prescribed form. • Submit the completed form and including the required supporting documents to the Chamber of Tax Advisors and transfer the fee for processing the application. • The Chamber of Tax Advisors will check whether you meet the requirements and decide on your application. • The order is made by handing over a certificate. If you have any questions or need help with the application, the Rhineland-Palatinate Chamber of Tax Advisors will provide you with more information.
