This does not apply to the projects listed in § 64 Para. 7 LBauO.</p> <p>A person authorized to submit building proposals pursuant to Section 64 (2) LBauO is</p> <ol style="list-style-type: none"> <li>1. who is entitled to use the professional title of architect under the Architects Act,</li> <li>2. anyone who is entered in a list to be maintained by the Rhineland-Palatinate Chamber of Engineers; anyone who is entitled to use the professional title of engineer on the basis of the state law on the protection of professional titles in engineering and via the Rhineland-Palatinate Chamber of Engineers as a graduate of the field of civil engineering and who has subsequently been practically active in the field of object planning of buildings for at least two years must be entered in the list upon request; entry in a comparable list of another state of the Federal Republic of Germany is also valid in Rhineland-Palatinate,</li> <li>3. anyone who is entitled to use the professional title of interior designer under the Architects Act for the</li> </ol> |
