| Hinweise                     | <p>You would like to complete part of your training here and have already received a residence permit for training purposes in another EU member state: In most cases, you will also receive a residence permit for Germany.</p> <p>You have a residence permit for other purposes (e.g. for family reasons) or a settlement permit: In this case, you can take up training in Germany without an additional residence permit.</p> <p>If you complete qualified vocational training in Germany, you are allowed to work up to ten hours a week, regardless of the training. After successfully completing the qualified vocational training, the authorities can extend your residence permit by up to one year under certain conditions. During this time</p> <ul style="list-style-type: none"> <li>• you can look for a job appropriate to your qualification, provided it can be filled by foreign nationals, and</li> <li>• may work without restriction.</li> </ul> |

Depending on where you live, the foreigners authority is the district administration or the municipal administration of the independent city.</p> <p>Citizens of Australia, Israel, Japan, Canada, the Republic of Korea, New Zealand and the United States of America can enter Germany without a visa, regardless of the purpose and duration of their stay. They must apply for a residence permit within three months of entering Germany at the immigration authority responsible for their place of residence.</p> |
