| Teaser                   | If you receive Citizen's Income and would like to improve your employability, you can be assigned to a work opportunity by the Jobcenter.  |
| Volltext                 | Have you been unemployed for a long time, possibly<br>with health restrictions and would like to get back on<br>your feet professionally? A work opportunity gives you,<br>as a recipient of citizen's allowance, the opportunity to<br>carry out an activity that prepares you for employment<br>on the labor market.   |
|                          | The activities to be carried out must be additional, non-competitive and in the public interest.   |
|                          | A work opportunity can only be considered if your<br>integration into the labor market cannot be achieved<br>with other benefits. A work opportunity usually lasts up<br>to 24 months. It can be extended by up to 12 months.  |
|                          | Work opportunities are carried out by a suitable<br>organization. This can be, for example, an educational<br>institution, a charitable and welfare-oriented company<br>or a non-profit association.   |
|                          | The working hours are determined by the Jobcenter on a case-by-case basis.   |
|                          | Your contact person at the Jobcenter will assign you a<br>work opportunity. In addition to your Citizen's<br>Allowance, you will receive an additional expense<br>allowance, for example for additional travel costs or<br>work clothing. The amount of the additional expense<br>allowance is based on the actual expenses incurred as<br>a result of participating in the work opportunity. You<br>will only receive the additional expenses allowance for<br>hours in which you have actually performed work, i.e.<br>not for sick leave, vacation days, weekends and public<br>holidays. |
|                          | You are insured against accidents through your training provider.  |

Your work must therefore serve the general public, not commercial interests or a limited group of people. be competition-neutral, i.e. no regular employment relationship may be displaced or prevented.</li> </ul> |

Measure costs, i.e. necessary material and personnel costs that arise directly from the implementation of the work opportunity, are reimbursed to the measure provider.</li> <li>The decision to participate in a work opportunity is at the discretion of the Jobcenter. There is no legal entitlement to funding.</li> </ul> |
