Volltext	You can change the name of your child if you do not exercise joint custody with the other parent until after the birth.
Erforderliche Unterlagen	• Birth certificate of child (with official translation if necessary) • Identity cards or passports • Marriage certificate or • Proof of guardianship In individual cases, further documents may be required. You can enquire about these at the registry office.
Voraussetzungen	• child already has a name • Joint custody of the parents is only established afterwards • if the child is 5 years or older: consent of the child

Verfahrensablauf	You can submit the declaration of name change at any registry office. You must have it certified either by a notary or a registrar. The declaration becomes effective as soon as it reaches the registry office. You will receive a certificate of the name change. The marriage register and the birth register are updated.

Frist	The new birth name must be determined within 3 months of the establishment of joint custody of the child.
