leading a self-determined life, integration assistance can be applied for. This integration assistance is aimed at children and young people with a mental disability or the threat of a mental disability.

Eligible young people can submit an application themselves from the age of 15. Before the age of 15, their legal representatives submit an application on their behalf.

Integration assistance is divided into 4 groups:

- Benefits for medical rehabilitation
- Benefits for participation in working life
- Benefits for participation in education and
- Benefits for social participation

There are different forms of integration assistance, such as

- outpatient, outside of inpatient facilities, for example school support,
- Day facilities for children or other day-care facilities,
- day and night facilities and other forms of accommodation,

placement in full-time care (for suitable persons).
