Voraussetzungen	Helplessness • A disabled person is helpless if they require permanent assistance from others for a series of frequently and regularly recurring tasks to secure their personal existence in the course of each day.

Sachverhalt

These conditions are also met if:

- the assistance is required in the form of supervision or guidance or
- the assistance does not have to be provided on a permanent basis, but constant readiness to provide assistance is required.

Helplessness is assumed in the case of the following illnesses:

- Blindness and severe visual impairment
- paraplegia and other disabilities that require the permanent and constant use of a wheelchair - even within the living space
- brain damage, seizure disorders, mental disability and psychoses, if these disabilities alone result in a GdS of 100
- Loss of two or more limbs, with the exception of amputation of the lower leg or foot on both sides
