Erforderliche Unterlagen	The registration of a limited partnership must contain • the surnames, first names, dates of birth and places of residence of all partners • the name of the company and the place where it has its registered office, as well as the domestic business address • the power of representation of the partners • all limited partners and the amount of the contribution of each of them The registration must indicate the location of the business premises, which differs from the domestic business address, and the object of the company,

	insofar as this is not apparent from the company name.
Voraussetzungen	There must be a partnership agreement.
Kosten	The fees for entry in the commercial register depend on the amount of work involved.
Verfahrensablauf	Registration To submit an application, please contact a notary. • The notary will advise you on how to formulate the application. • The application is made exclusively by electronic means and a publicly notarized document is created for this purpose. • The declaration is provided with an electronic signature (in accordance with § 39a Beurkundungsgesetz/BeurkG) and sent to the electronic court and administrative mailbox of the registry court. Changes Have important details about your company, such as the registered office, legal form or authorized representatives, changed? Then please have the commercial register entry corrected immediately. The entry is made in the same way exclusively via a notary.
