	<p>**at least 15 years, but not yet 18 years (young people):**</p> <ul style="list-style-type: none"> • no piecework, night work or weekend work (exceptions apply e.g. in the catering industry, bakeries and supermarket sales outlets) • Working hours: <ul style="list-style-type: none"> • from 6 a.m. to 8 p.m. (exceptions apply in certain sectors) • maximum 8 hours per day and 5 days per week (maximum 40 hours per week; exceptions apply in agriculture) • as a young person required to attend school full-time, such as children, you may work for a maximum of 4 weeks per calendar year during the school vacations

Volltext	<p>**Vacation job**</p> <p>With a vacation job, you can gain your first impressions of the world of work as a school pupil from the age of 15 and make contact with potential employers.</p> <p>Vacation jobs in the non-commercial sector, for example in the household, for churches or clubs and on farms, are possible from the age of 13.</p> <p>Special legal regulations apply to protect children and young people from excessive demands, overwork and the associated dangers in the workplace.</p> <ul style="list-style-type: none"> • With regard to the duration of work, a vacation job is limited to a maximum of 50 working days per year or 2 months at a time with a 5-day week. • The Youth Employment Protection Act applies for young people who are required to attend school full-time in conjunction with the Child Employment Protection Ordinance. • Anyone who is at least 18 years old is not subject to any special restrictions with regard to the type of work and working hours. The Working Hours Act applies.
