This demand-oriented energy performance certificate calculates the energy requirement based on the condition of the building envelope and the building services, assuming average user behavior. In the simplified procedure, the data is recorded via a typology of the building form, components, year of construction, etc., while the detailed procedure records the building to be examined and its building services in detail.
