Teaser	If you hold a Bundeswehr, Federal Police or police service driving licence, you can have it converted into a general driving licence.
Volltext	A business driving licence acquired on official duty can be converted into a "civilian", i.e. general driving licence. With a company driving license from the Bundeswehr, the Federal Police and the police, you may only drive official vehicles. It applies only for the duration of the employment relationship. Please note: Card driving licences issued from 19 January 2013 onwards are limited to 15 years. However, the time limit only applies to the driving licence document. This must be renewed every 15 years. Regular medical examinations or other examinations are not associated with the exchange of documents.
