What are the advantages of the electronic income tax return (ELSTER)?

Commercial tax return programs or the free service portal »ELSTER: Ihr Online-Finanzamt« of the tax authorities can be used for the electronic tax return. The electronic transmission offers active completion aids as well as functions for tax calculation and reconciliation. Under www.elster.de you will find all further information on the electronic submission of a tax return.

How does the service portal »ELSTER: Ihr Online-Finanzamt« work?

The tax portal »ELSTER: Your online tax office« offers you the possibility of electronic transmission of your tax return. This electronic and partly already paperless variant of the tax return is provided to you free of charge by the tax authorities.
