Volltext	Card driving licenses issued as of 19.01.2013 have a validity of 15 years. If the validity of the driver's license is about to expire or has expired, you must apply for a new driver's license unless you surrender the driver's license. However, the time limit only affects the driver's license document, not the underlying driver's license.
