| Volltext                 | If you wish to leave a religious community, you must register this with the responsible office.  |
| Erforderliche Unterlagen | Identity card or passport or foreign ID with a<br>confirmation of registration that is not older than six<br>months. You can also provide details of the place of<br>baptism. However, this information is voluntary.  |
| Voraussetzungen          | You can declare your withdrawal from a church,<br>religious community or ideological community if you<br>have reached the age of 14. If you have not yet reached<br>the age of 14, your legal representative who has<br>custody of you (parents or, if applicable, one parent)<br>can declare your withdrawal from the church. Children<br>who have reached the age of 12 cannot declare their<br>withdrawal against their will.   |

| Verfahrensablauf         | You must submit the declaration of withdrawal from the church in person to the responsible office. The   |

|                                 | resulting change in religious affiliation under<br>registration law is transmitted electronically by the<br>responsible office to the Federal Central Tax Office<br>(BZSt). The employer is automatically informed of the<br>withdrawal from the church by retrieving the electronic<br>wage tax deduction features (ELStAM), which are<br>stored at the Federal Central Tax Office. It is therefore<br>not necessary for you to contact the tax office.  |

| Frist                           | The declaration of resignation shall take effect at the<br>end of the day on which the minutes of the declaration<br>of resignation have been signed or the written<br>declaration has been received by the competent<br>authority. The obligation to pay church tax ends at the<br>end of the month in which the declaration becomes<br>effective.   |
