Volltext	For export to non-EU countries, animals must generally meet certain requirements of the country of destination and be accompanied by a health certificate in which compliance with the health requirements for export is confirmed by an official veterinarian or official veterinarian. This applies in particular to mammals, birds, fish, but in some cases also to amphibians, reptiles, insects, arachnids, molluscs and other animals. Animals that do not meet the health requirements may not be exported. The same applies to movements between Member States of the European Union.
Erforderliche Unterlagen	The health certificates required in each case depend on the country of destination and may need to be obtained from the embassy or authorities of that country.
Voraussetzungen	
Kosten	The amount of the fee varies greatly depending on the individual case.
Verfahrensablauf	First of all, the requirements of the country of

	destination of the export must be clarified. Then the animals must be examined for export and a health certificate must be issued.
Bearbeitungsdauer	The processing times vary greatly depending on the individual case.
Frist	Any deadlines to be met depend on the requirements of the country of destination, in particular the health requirements to be certified, and can vary greatly depending on the animal species and the country of destination.

Kurztext	Animals exported to non-EU countries must generally meet certain requirements of the country of destination and be accompanied by a health certificate.
