Cybercrime includes all criminal offenses that are directed against the internet, data networks, IT systems and their data or that are committed using IT, for example • Data/identity theft, • data theft, • online extortion by means of: • DDoS (Distributed Denial of Service) or • ransomware/cryptotrojans, • Man-in-the-middle attack and • CEO fraud. You can also contact us if you would like advice on measures to prevent cybercrime. The ZAC office of the federal state in which your company is based is responsible for you.
