Teaser	You can have your residence permit extended before the end of your period of validity in order to continue your studies started in another EU country if you meet certain requirements for this purpose.
Volltext	The residence permit for the continuation of studies started in another EU country is a temporary residence permit. The residence permit is extended for the duration of the mandatory period of study or the exchange programme that is carried out in Germany. The same conditions apply to the extension of your residence permit as to the issue. In particular, your livelihood should be secured for the duration of your studies in Germany. As a rule, the residence permit cannot be renewed if this has already been ruled out when the residence permit was issued or the last extension.

Voraussetzungen	<ul> <li>You have a recognised and valid passport or passport replacement as well as the valid residence permit for the continuation of studies started in another EU country in accordance with § 16b paragraph 7 of the Residence Act.</li> <li>The period of validity of your residence permit will expire in the near future.</li> <li>There is no interest in expulsion against you.</li> <li>Your stay does not endanger or affect the interests of the Federal Republic of Germany.</li> <li>Your livelihood is secure.</li> <li>You can prove a place at university.</li> </ul>
Kosten	<ul> <li>Extension of the residence permit for the purpose of studying for persons entitled to international protection</li> </ul>
	<ul> <li>for a further stay of up to three months: EUR 96</li> <li>for a further stay of more than three months: EUR 93</li> </ul>
	• Under certain conditions, a reduction in fees or exemption from fees may be considered.
Verfahrensablauf	<ul> <li>The extension of your residence permit must be applied for at the immigration office responsible for your place of residence.</li> <li>Depending on the immigration office and concerns, an application via the Internet may be possible. Find out whether your immigration office offers the electronic application for the residence permit.</li> <li>If the application is only possible in person, arrange a preliminary appointment with the immigration office.</li> <li>During the appointment, your application will be accepted and your proofs checked (please bring them with you to the appointment). For the issuance of the electronic residence title (eAT), your fingerprints will be taken.</li> <li>In the event of an electronic application, the Immigration Office will contact you after receipt of your opline application in order to arrange an appointment</li> </ul>
