Hinweise	You can also shorten your training period if you have a high school diploma or have already completed vocational training. You can also shorten the training period if you have already gained work experience in part-time jobs. If you have already acquired the skills and knowledge elsewhere, you can also apply to shorten the training period. Each training occupation has a minimum training period that you must complete.

Kurztext	• Previous vocational training and higher-level school qualifications can be credited towards the training period. • This can shorten the training period. • The following periods can be credited: Attendance at a vocational school, Vocational preparation program, School-leaving qualifications from secondary school • Applications must be submitted jointly by the trainee and the training company.
