Teaser	<p>The aptitude test is a special form of the tax consultant examination. If you have a professional qualification from another European country, you are entitled to pass the aptitude test for self-employment and to bear the title of "tax consultant" in Germany.</p>
Volltext	<p>Applicants with a certificate of competence or training entitling them to self-employed assistance in tax matters in another Member State of the European Union or a state party to the Agreement on the European Economic Area or in Switzerland and who would like to work as a tax consultant in Germany can take an aptitude test upon application. With the successfully passed aptitude test, the same rights are acquired as through the successfully passed tax consultant examination.</p> <p>The aptitude test is a state examination. The examination consists of a maximum of two written proctoring papers and one oral examination. The examinations are approved by the State Examination Board of the Ministry of Finance of Rhineland-Palatinate.</p>

Erforderliche Unterlagen	You must submit an application for admission to the aptitude test together with the required attachments.
Voraussetzungen	The aptitude test can only be taken if you have previously been admitted to the exam.
Kosten	Gebühr: 200€ For the processing of the application for admission to the aptitude test - even if the application is submitted repeatedly, Gebühr: 1.000€ Fee for the examination procedure
Verfahrensablauf	If you have been admitted to the aptitude test, you will take part in the written proctoring papers. If the overall grade for the written exam does not exceed 4.5, you will be invited to the oral exam. The aptitude test must be taken before an examination board at the highest tax authority of the federal state in which you would like to practice the profession of tax consultant in the future. In Rhineland-Palatinate, this is the Ministry of Finance.

Rechtsbehelf	If the aptitude test is not passed, the action before the fiscal court is admissible.
Kurztext	The aptitude test is a state examination for applicants who have acquired a certificate of competence or training, which entitles them to self-employed assistance in tax matters in another member state of the European Union or a state party to the Agreement on the European Economic Area or in Switzerland, and who would like to work as a tax consultant in Germany.
