Teaser	As a researcher, you can obtain a residence permit for the purpose of research under certain conditions
Volltext	You can obtain a residence permit for the purpose of research if you are recognized as a beneficiary of international protection in an EU member state and have resided in this state for at least two years after being granted protection.
	The residence permit for the purpose of research for beneficiaries of international protection is a temporary residence permit. It is issued for the duration of the research project.
	The residence permit entitles the holder to take up research activities at the research institution specified in the hosting agreement and to take up teaching activities. Changes to the research project during the stay do not result in the loss of this authorization.

	<ul> <li>Proof of the status of the beneficiary of international protection in another EU Member State</li> <li>Proof of length of stay in the EU Member State granting protection status</li> <li>Hosting agreement or a corresponding contract with a research institution to carry out the research project</li> <li>Proof of livelihood</li> <li>Proof of your health insurance</li> <li>Tenancy agreement</li> </ul>
Voraussetzungen	<ul> <li>You have a recognized and valid passport or passport substitute.</li> <li>There is no interest in deporting you.</li> <li>Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.</li> <li>You have concluded a hosting agreement or a corresponding contract to carry out a research project with a research institution in Germany.</li> <li>You have the status of a beneficiary of international protection or a beneficiary of international protection in another EU Member State where you have resided for at least 2 years after being granted protection.</li> <li>You have a declaration of assumption of costs from the research institution. In principle, the research institution must undertake in writing to assume the costs, the public authorities up to six months after the end of the hosting agreement or contract. This includes the costs for the foreigner's living expenses during an unauthorized stay in an EU member state and for deportation. In certain cases, the declaration of assumption of costs is not required. Please contact your local immigration office in this regard.</li> <li>You can cover your living expenses and health insurance from your income without claiming public benefits.</li> </ul>
Kosten	Issuance of a residence permit for the purpose of research for beneficiaries of international protection: EUR 100 Under certain conditions, a fee reduction or fee exemption may be possible.
Verfahrensablauf	You must apply for a residence permit at the foreigners authority responsible for your place of

	residence. The procedure is as follows:
	<ul> <li>Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic applications for residence permits.</li> <li>If you can only apply in person, make an appointment with the immigration office. During the appointment, your application will be accepted and your supporting documents checked (bring these with you to the appointment). Your fingerprints will be taken for the production of an electronic residence permit (eAT card).</li> <li>In the case of an electronic application, the Immigration Office will contact you after receiving your online application to arrange an appointment at the Immigration Office if necessary. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the appointment).</li> <li>If your application is approved, the Foreigners' Registration Office will arrange for the eAT card to be issued.</li> <li>After about six to eight weeks, you can collect the eAT card from the immigration office.</li> <li>The eAT card must always be collected in person.</li> </ul>
Bearbeitungsdauer	about 6 to 8 weeks. If you have concluded a hosting agreement or a corresponding contract with a research institution that is recognized to carry out the special admission procedure for researchers in Germany, the immigration authority must issue the residence permit within 60 days of the application being submitted. The list of recognized research institutions and information on this can be found under "Further information".
Frist	<ul> <li>Application for a residence permit for the purpose of research for beneficiaries of international protection: no later than eight weeks before your valid visa expires</li> <li>Objection period: 1 month</li> </ul>

Kurztext	<ul> <li>Residence permit for the purpose of gainful employment Issued to researchers who are recognized as refugees or similar in another EU member state</li> <li>Foreigners who have concluded a hosting agreement or a corresponding contract with a research institution to carry out the research project in Germany and who are recognized as beneficiaries of international protection in another EU member state and have resided in this EU member state for at least two years after being granted protection may be granted a residence permit for the purpose of research.</li> <li>The residence permit entitles the holder to take up research activities at the research institution specified in the hosting agreement and to take up teaching activities.</li> <li>The residence permit for the purpose of research for beneficiaries of international protection is a temporary residence permit. It is issued for the duration of the research project.</li> <li>Holders of a residence permit for the purpose of research can receive a settlement permit after fulfilling certain requirements.</li> <li>Spouses of holders of a residence permit for the purpose of research are also entitled to a residence permit.</li> <li>Depending on the foreigners authority and the matter in question, applications can be made online or in person.</li> </ul>

	<ul> <li>A fee is payable for the issue of the residence permit. The time and form of payment vary depending on the authority.</li> <li>Responsible: the foreigners authority responsible for the applicant's place of residence</li> </ul>
