Teaser	You have the right to ensure that the data that an authority processes about you, for example, is correct. You should therefore request the rectification of your data if you notice that incorrect data about you is being processed.
Volltext	The registration authority is obliged to correct or complete incorrect or incomplete personal data. If you discover that the registration authority is processing incorrect or incomplete personal data about you, you can request the correction or completion of this data informally. The authority will then check whether the data is actually incorrect or incomplete. If this is the case, the data will be corrected or completed.
Erforderliche Unterlagen	In order to prove that the processed personal data is incorrect or incomplete, it may be necessary to provide documents showing the correct data.
Voraussetzungen	The prerequisites for a correction are, on the one hand, incorrect or incomplete data and, on the other hand, the unequivocal determination of the incorrectness or incompleteness. The registration authority must also be aware of the correct data.
Kosten	free of charge

Verfahrensablauf	As soon as you have requested a correction of incorrect personal data and the authority determines that the data is actually incorrect, the correction will be made if the authority is aware of the correct data. You will be informed of the result of the examination of your request for rectification. The registration authority will also inform those public bodies to which the incorrect or incomplete data has been transmitted as part of regular data transmissions in accordance with the Federal Registration Act.
Bearbeitungsdauer	Minor. In simple cases, rectification takes place immediately; however, it may take time to check whether the personal data is actually incorrect and to determine the correct data.
