Volltext	As the operator of a new plant, you are obliged to notify it to the competent authority no later than one month after the first filling with useful water. Existing plants had to be notified by 20 August 2018. In addition, changes to the installation and a plant closure must be notified without delay, at the latest within one month. In the event of a change of operator, the new operator shall notify the competent authority of this change without delay, but at the latest within one month.

## Frist

The operator of a new installation shall notify the competent authority of the latter no later than one month after the first filling with useful water. Existing installations had to be notified to the competent authority no later than one month after 19 July 2018. Changes to the plant, plant shutdown and operator change must be notified without delay and at the latest within one month.
