| Teaser | You would like to serve alcoholic beverages commercially? For this you need a liquor license. You can find out more here. |
| Volltext | You would like to serve alcoholic beverages? A liquor license is required for this. |
| | Only the serving of non-alcoholic beverages is exempt from this requirement. You also need a liquor license if alcoholic beverages are not offered within a purely gastronomic business, but as an ancillary service to another business (e.g. serving alcoholic beverages as part of a sales transaction - refreshment bar in a department store; tasting to increase sales of alcoholic beverages). If you intend from the outset to limit the serving of |
| | alcoholic beverages to a certain period of time (e.g. summer season, Christmas period, etc.), you can apply for a temporary liquor license. |
| | The permit to serve alcoholic beverages is always granted for a specific type of operation (e.g. pub, discotheque, etc.) and for specific premises. |
| | If you wish to serve alcoholic beverages for specific occasions (e.g. city festivals, shooting festivals, fairs and music events), you need a special permit, which you can obtain under simplified conditions. For this purpose, you must submit an "Application for Temporary Permission to Operate a Restaurant". |
| Begriffe im Kontext | |
| Bearbeitungsdauer | If the documents are complete, the application will be processed promptly. |
| Fristen | Before you start operating, you must have a restaurant license. A timely application is therefore required. |
| | If the authority has not made a decision on an application for permission to operate a trade within a period of three months after receipt of the complete documents (§ 42 Abs. 2 Satz 2 Verwaltungsverfahrensgesetz), the permission is |





deemed to have been granted (§ 6 a Abs. 1 GewO).

This also applies to procedures under the Catering Act, as long as there are no regulations under Land law (§6a Para.2 GewO).

You must notify the authority responsible for trade notifications according to § 14 GewO of the start of the permitted activity.

- * Licence
- * The serving of alcoholic beverages requires a liquor license.
- * Permission is also required if the serving of alcoholic beverages is only offered as an ancillary service to another trade (e.g. serving alcoholic beverages in the refreshment room of a department store).
- * Only the serving of non-alcoholic beverages is exempt from licensing.
- * Entitlement to the granting of a permit if there are no grounds for refusal according to § 4 Para. 1 Sentence 1 No. 1 to 4 GastG.
- * Permission is type of business (in the case of pure serving: public house) and room-related.
- * If, in addition to the serving of alcoholic beverages, prepared meals are also offered, a restaurant permit for a different type of operation must be applied for.
- * A liquor license can be limited in time (e.g. for the summer season) or linked to ancillary provisions (e.g. for compliance with immission control regulations).
- * If alcoholic beverages are served for a specific occasion (e.g. as part of a particular event), a permit must be applied for.
