Teaser	If you want to drive into an environmental zone, you need a fine dust sticker/ environmental badge. You can get information here.
Volltext	Clean air plans exist for areas with poor air quality. Clean air plans contain measures to improve air quality. Environmental zones are one possible measure of such clean air plans. Environmental zones reduce particulate matter and nitrogen dioxide pollution. Vehicles with high pollutant emissions are not allowed to drive in environmental zones.  If you want to drive your vehicle in such an environmental zone, you must purchase a fine dust sticker/environmental sticker. The sticker is available in three different colors, each of which is assigned to a pollutant group. The classification of your vehicle into one of the pollutant groups is based on the emission code numbers. You can find these in the vehicle documents.
