Volltext	The driving licence for the carriage of passengers (FzF) for taxis is issued for a maximum of five years and can be extended for up to five years at the holder's request. Attention: If the application is made after the expiry of the FzF, an extension is no longer possible. The issuance of a new FzF must be applied for.
Erforderliche Unterlagen	• official proof of place and date of birth (e.g. identity card or passport) • If applicable, current certificate of registration • EU/EEA driving licence • Certificate of good conduct for submission to an authority (service description in Hessenfinder) • Current information from the driver suitability register • Proof of physical and mental fitness • Proof of meeting the requirements for eyesight • Proof of the ability to cope with stress, orientation, concentration, attention and reaction (in case of extension beyond the age of 60)
