In doing so, it is essential to</p> <ul style="list-style-type: none"> • focus on shared living and integration into society, • the Housing and Care Act applies, • the level of care is largely the same as the care in a fully stationary facility. <p>If you claim a pro-rata care allowance for the days on which you are cared for and cared for at home, the days of arrival and departure are considered to be full days of home care.</p>
