| Teaser                           | You can obtain a Mobiler-ICT card if you come from a country outside the EU or the EEA and wish to work in a German branch of a foreign company for longer than 90 days.  |
| Volltext                         | You can obtain a Mobile ICT Card if you are to work as<br>a manager, specialist or trainee in a German branch of<br>a foreign company.  |
|                                  | The Federal Employment Agency must approve your<br>employment. In particular, the Federal Employment<br>Agency will check your activity as a manager, specialist<br>or trainee as well as your salary and working<br>conditions.  |
|                                  | The residence permit is issued for the duration of the internal transfer within the company, but for at least 90 days. However, the stay in Germany may not exceed three years for managers/specialists and one year for trainees. At the same time, the planned stay in Germany may not be longer than the stay in the EU member state that issued the residence permit for the purpose of the intra-company transfer. |

|                   | <ul> <li>Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic applications.</li> <li>If the application can only be made in person, make an appointment with the immigration office. During the appointment, your application will be accepted and your supporting documents checked (bring these with you to the appointment). Your fingerprints will be taken to produce the MobilerICT card.</li> <li>In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your online application to arrange an appointment at the Foreigners' Registration Office if necessary. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the mobile ICT card.</li> <li>If your application is approved, the Foreigners' Registration Office will arrange for the Mobile ICT Card to be issued.</li> <li>After about six to eight weeks you can collect the MobilerICT card from the immigration office.</li> <li>Thee Mobile ICT Card must always be collected in person.</li> </ul> |

| Rechtsbehelf                    | An appeal against a decision by the immigration<br>authority can be lodged with the authority named in<br>the decision within one month of notification of the<br>decision. The appeal may be lodged in writing, in<br>electronic form or for the record.<br>If the foreigners authority does not uphold the appeal,<br>an action may be brought before the court named in<br>the notice of appeal.   |
| Kurztext                        | <ul> <li>Mobile ICT card issue</li> <li>Foreign nationals who hold a valid residence permit<br/>for the purpose of an intra-company transfer from<br/>another EU member state and who wish to work in a<br/>German branch of their company for longer than 90<br/>days can obtain a "Mobile ICT Card". The Federal<br/>Employment Agency must approve the employment in<br/>Germany.</li> <li>The MobilerICT card is issued for the duration of the<br/>intra-company transfer. However, the stay in Germany<br/>as part of the intra-company transfer may not exceed<br/>three years for managers/specialists and one year for<br/>trainees.</li> <li>The planned stay in Germany may not be longer than<br/>the stay in the EU Member State that issued the<br/>residence permit for the purpose of the<br/>intra-corporate transfer.</li> <li>If the foreign person is already staying in Germany as<br/>part of short-term mobility, the application for a<br/>"MobilerICT card" must be submitted at least 20 days<br/>before the end of the stay for short-term mobility.</li> <li>If applying from abroad, the application must be<br/>submitted at least 20 days before entering Germany.</li> <li>Depending on the foreigners authority and your<br/>request, you can apply online or in person.</li> <li>A fee is charged for the issue of the</li> </ul> |
