Teaser	After recognition of your foreign professional qualification, you can be granted a residence permit directly afterwards to take up a corresponding employment relationship or self-employment for a minimum of 12 months.
Volltext	If the equivalence of your foreign professional qualification has been established or you have received the professional qualification, you can be granted a temporary residence permit to look for a job or to take up self-employment directly after your previous recognition procedure. This residence permit allows unrestricted employment.
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Valid national passport</li> <li>• Proof of secure livelihood (e.g. employment contract and pay slips, bank statements, submission of a declaration of commitment by third parties)</li> <li>• Proof of health insurance</li> <li>• Proof of qualification (certificate of completion, certificate or certificate from your training company or educational institution about the successful completion of an apprenticeship)</li> <li>• 1 current biometric photo</li> </ul>

	<ul style="list-style-type: none"> <li>• Please ask the immigration office responsible for you whether you need to submit further documents.</li> </ul>
Voraussetzungen	<p>You already have a residence permit for the purpose of the recognition procedure of a foreign professional qualification in Germany. The other general conditions for obtaining a residence permit are in particular:</p> <ul style="list-style-type: none"> <li>• a secure livelihood,</li> <li>• a clarified identity,</li> <li>• Possession of a valid national passport.</li> </ul>
Kosten	Gebühr: 98€
Verfahrensablauf	<p>You can only submit an application for a residence permit in person to the immigration authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• You submit the required documents in the original and pay the application fee.</li> <li>• The Immigration Office checks whether the grant requirements are met.</li> <li>• If all requirements are met, the Immigration Office will take up your biometric data (photo, fingerprints) and order the electronic residence title (eAT) from Bundesdruckerei GmbH.</li> <li>• As soon as the eAT is completed, it will be handed over to you by the Immigration Office.</li> </ul>
Bearbeitungsdauer	The processing time depends on the capacity utilization in the local immigration office.
Frist	Application before the expiry of the current residence permit. An interview 4 to 6 weeks before the previous residence permit expires is recommended. The residence permit is limited to a period of 12 months at the most.
