Teaser	You can obtain a residence permit if you intend to start a self-employed activity.
Volltext	To start a self-employed activity, you can apply for a temporary residence permit.  A residence permit is a residence permit. The granting of the residence permit is only possible for a specific purpose, such as, among other things, for taking up a self-employed activity.
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Valid national passport</li> <li>• proof of health insurance;</li> <li>• lease</li> <li>• Curriculum vitae and proof of qualification about previous activities and training (final certificates, certificates or certificates)</li> <li>• Financing plan / business plan</li> <li>• 1 current biometric photo</li> <li>• Please ask the immigration office responsible for you whether you need to submit further documents.</li> </ul>
Voraussetzungen	<p>The residence permit can only be issued to you if:</p> <ul style="list-style-type: none"> <li>• there is an economic interest or a regional need in</li> </ul>

	<p>the activity, and</p> <ul style="list-style-type: none"> <li>• the activity can be expected to have a positive impact on the economy in Germany, and</li> <li>• the financing of the implementation is secured by equity capital or by a loan commitment.</li> </ul> <p>If you have already reached the age of 45, an adequate pension is also required.</p> <p>Furthermore, the general conditions for obtaining a residence permit must be met.</p> <p>These are in particular:</p> <ul style="list-style-type: none"> <li>• a secure livelihood,</li> <li>• a clarified identity,</li> <li>• Possession of a valid national passport.</li> </ul>
Kosten	Gebühr: 100€
Verfahrensablauf	<p>You can only submit an application for a residence permit in person to the immigration authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• You submit the required documents in the original and pay the application fee.</li> <li>• The Immigration Office checks whether the grant requirements are met.</li> <li>• If necessary, the participation of other authorities takes place.</li> <li>• If all requirements are met, the Immigration Office will take up your biometric data (photo, fingerprints) and order the electronic residence title (eAT) from Bundesdruckerei GmbH.</li> <li>• As soon as the eAT is completed, it will be handed over to you by the Immigration Office.</li> </ul>
Bearbeitungsdauer	The processing time depends on the workload in the local immigration office.
Frist	Application before the expiry of the current residence permit. An interview 4 to 6 weeks before the previous residence permit expires is recommended. The residence permit is issued for a maximum of 3 years.
