Teaser	Would you like to work as a nurse in Germany? Then you need a state permit. In order to obtain the state permit, you must submit an application and have your foreign professional qualification recognized.
Volltext	<p>The profession of nurse is regulated in Germany. This means that in order to work as a nurse in Germany, you need a state permit. With the permit, you are allowed to use the professional title "nursing specialist" or "nursing specialist" and work in the profession.</p> <p>Even if you have a professional qualification from a so-called third country, you can obtain a state permit from the competent authority in Germany. Third countries are all countries that do not belong to the European Union (EU), the European Economic Area (EEA) or Switzerland. In order to obtain the permit, you must have your foreign professional qualification recognised. In the recognition procedure, the competent authority compares your professional qualification from abroad with the German professional qualification and checks its equivalence. The equivalence of the professional qualification is an important prerequisite for the issuance of the state permit.</p> <p>In addition to the equivalence of the professional qualification, you must also meet other requirements</p>

for the issuance of the permit. Other requirements are, for example, sufficient German language skills and health suitability.

If your professional qualification comes from the EU, EEA or Switzerland, different regulations apply. You can also apply for the procedure from abroad.

Erforderliche Unterlagen

The competent authority will tell you which documents you need to submit. Important documents are in general:

- Proof of identity (ID card or passport)
- Marriage certificate (if your name has changed as a result of marriage)
- Curriculum vitae
- Proof of your professional qualification (e.g. certificates, professional certificate)
- Proof of education
- Proof of your relevant professional experience in a profession comparable to that of a nurse
- Proof of other relevant knowledge for working as a nursing specialist
- Do you still live or work in a third country, i.e. not in the EU, the EEA or Switzerland? Then you may need to prove that you have been accepted by a health and care facility to work as a nurse in Germany.

You will usually submit these documents later. The competent authority will inform you when you should hand in the documents:

- Proof of your personal suitability: extract from the criminal record or certificate of good conduct from your country of origin.
- Proof of your health suitability: Medical certificate.
- Proof of your German language skills: Language certificate

	<p>The competent authority will inform you which documents you need to submit as a simple copy, as a certified copy or in the original.</p>
Voraussetzungen	<ul style="list-style-type: none"> • You have a comparable professional qualification as a nurse from a third country. • You want to work as a nurse in Germany. • Personal suitability: You are reliable to work as a nurse and have no criminal record. • Health suitability: You can work mentally and physically as a nurse. • You have German language skills at the required level. This is usually language level B2 according to the Common European Framework of Reference for Languages (CEFR).
Kosten	<p>The competent authority will inform you about the costs. The costs generally depend on the amount of work involved.</p> <p>In addition, there may be additional costs (e.g. for translations, certifications or compensatory measures such as an adaptation period or a knowledge test). These costs vary from person to person.</p>
Verfahrensablauf	<p>**Application**</p> <p>You submit an application to the competent authority for permission to use the professional title "nursing specialist" or "nursing specialist".</p> <p>You can apply if you do not yet live in Germany. You can submit the application with the documents to the competent authority or send it by post. Do not ship originals. Sometimes you can also send the application electronically. The competent authority will inform you.</p> <p>**Equivalence test**</p> <p>The competent authority will then check whether you meet all the requirements. An important prerequisite is the equivalence of your professional qualification. The competent authority compares your professional</p>

qualification with the German professional qualification as a nursing specialist. The professional qualification is equivalent if there are no significant differences between your professional qualification and the German professional qualification.

****Possible results of the exam****

If your foreign professional qualification is equivalent, it will be recognised. The competent authority can confirm the result in writing. You still have to meet the other requirements. Then you will receive permission to use the professional title "nursing specialist" or "nursing specialist".

Are there any significant differences between your professional qualification and the German professional qualification? You may be able to make up for the differences through your work experience, other knowledge, skills or competences (lifelong learning). Knowledge, skills and competences must be certified by an authority of the state in which you acquired the knowledge, skills or competences.

However, it may not be possible to compensate for the significant differences in your professional experience, knowledge, skills or competences. In this case, the competent authority will tell you the main differences between your professional qualification and the German professional qualification and why you cannot compensate for these significant differences.

The competent authority will also tell you about compensatory measures that you can take to compensate for the significant differences. If you decide not to take compensatory measures, your professional qualification will not be recognised and you will not be allowed to work as a nurse in Germany.

****Compensatory measures****

There are various compensatory measures:

- Adaptation period: The adaptation period lasts a maximum of three years.

- Knowledge test: The knowledge test tests your knowledge in specific subjects and areas. The knowledge test consists of an oral and practical part.

You can choose between an adaptation period or a knowledge test.
If you successfully complete the compensatory measure and meet all other requirements, you will be granted permission to use the professional title "nursing specialist".

Bearbeitungsdauer

4 Monat(e)
The competent authority will inform you if any documents are missing. If the documents are complete, the procedure will take a maximum of 4 months.

Frist

There is no deadline. Sometimes documents are still missing from the procedure. The competent authority will then inform you by when you have to submit the documents.

****Certificate of equivalence****
In the licensing procedure, equivalence is also checked (recognition procedure). You can apply for a separate decision for the result of the examination.

****Procedure for ethnic German repatriates****
As a late repatriate, you can either go through the recognition procedure in accordance with the laws mentioned here or in accordance with the Federal Expellees Act. This is up to you. The competent authority will advise you on which procedure is right for you.

Rechtsbehelf

You can take legal action against the decision of the competent authority within a certain period of time (e.g. lodge an appeal). The decision will then be reviewed. Details on this can be found in the information on legal remedies at the end of your

decision. We recommend that you first talk to the competent authority before taking legal action against the decision.

The advisors will help you compile the necessary documents free of charge and throughout the entire recognition process.

Office hours are Monday to Friday 08:00 – 18:00 (CET). If you are abroad: You can also use the hotline to reach the Central Service Centre for Professional Recognition (ZSBA). This offers you in-depth advice and support in the recognition process and carries out a location consultation.
