Teaser	Are you registered in the register of skilled crafts with a craft that requires authorization and would like to practice another craft? Then you can apply for a license to practice another craft under certain conditions.
Volltext	Persons who already practice a craft subject to licensing and wish to expand their commercial activity to another craft subject to licensing or to essential activities of such a craft have the option of applying for a license to practice. In this respect, proof of the knowledge and skills required for this is required, whereby previous professional experience and activities are also taken into account. It is irrelevant on what basis the existing entry in the register of skilled crafts was made (e.g. master craftsman's certificate, old journeyman's regulation, exemption permit). The respective business owner is entitled to apply.  You can apply for an authorization to practice if you are  • you are already registered in the register of skilled crafts with a trade requiring approval.  • you wish to engage in another craft subject to licensing.  • you can provide evidence of your practical and

	If you do not have any proof or if it is not sufficient, you can also apply for an authorization to practice. In this case, you must then prove your knowledge by passing an expert examination.
Erforderliche Unterlagen	<ul> <li>Application for the issuance of an exercise authorization</li> <li>Proof of identification</li> <li>Proof of professional practical and theoretical knowledge in the craft subject to licensing for which you wish to be entered in the register of crafts. This includes:</li> <li>Work references,</li> <li>certificates of further education,</li> <li>certificates of having passed parts of the master craftsman's examination</li> <li>Confirmation of regular participation in preparatory courses.</li> </ul>
Voraussetzungen	<ul> <li>A craft subject to licensing is already being practiced on the basis of an existing entry in the register of crafts.</li> <li>Proof of the required knowledge and skills, taking into account previous professional experience and activities; possible means of proof are, for example, appraisals by experts, work certificates or further training.</li> <li>The standard for the proof of qualification is the masterly qualification for the craft subject to licensing for which the authorization to practice is being sought.</li> </ul>
Kosten	The specific fee results from the fee schedule of the Chamber of Crafts, which is available on the Chamber's website.
Verfahrensablauf	<ul> <li>Online application:</li> <li>Go to the website of your local Chamber of Skilled Crafts or to the service portal of your federal state and select the right online service.</li> <li>The online service will guide you through the application step by step.</li> </ul>

	local Chamber of Skilled Crafts along with the required evidence of your skills.  • Your application and the evidence will be examined by the Chamber of Skilled Crafts. If the evidence is not sufficient, you may be required to take an expert examination.  • After your documents have been checked, you will receive a license to practice and a notice of registration if the requirements are met.
Bearbeitungsdauer	
Frist	You can only exercise the other craft requiring authorization once it has been entered in the register of crafts. An authorization to practice must therefore be applied for at an appropriately early stage.

Rechtsbehelf	Legal action may be taken against a rejection of an application for entry in the register of skilled crafts. Depending on the federal state in which the application was submitted, a preliminary procedure must first be carried out. Information on the existing legal remedies can be found in the instructions on legal remedies in the notices.
