Volltext	If you want to hunt in Germany, you need a German hunting license in your name. If you already have a day hunting licence but its validity has expired, you can apply for an extension. You renew your hunting licence at the authority responsible for your place of residence. The day hunting licence is valid for 14 consecutive days.
