Teaser	You are a driver of a truck or bus and your driver card has been lost? Then you need to apply for a replacement card.
Volltext	The driver card is used to record driving times and rest periods in the commercial transport of goods and passengers. If you are a driver of trucks or buses and have lost your driver card, you can apply for a replacement card from the office responsible for you. From the time of loss, you may continue to drive without a valid driver card for a maximum of 15 days until you receive the replacement driver card. As long as you are not in possession of your driver card, you must record the driving and rest times manually. You must make printouts of these from the digital tachograph and carry them with you. The replacement driver card is valid until the same date as the lost original card - if it would have been valid for more than 6 months. Therefore, the validity period does not start all over again. When the replacement card is issued, the previous card loses its validity. If you do find it again, you must return the driver card to the responsible office or the Federal Motor Transport Authority (KBA). You may not continue to use it. Your employer is not obliged to reimburse you for the cost of the driver card.

	<ul> <li>Economic Area (EEA), respectively</li> <li>Proof of residence in Germany and address</li> <li>proof of birth and surname, first names, day and place of birth</li> <li>photograph against a light background, 35 mm x 45 mm in size, showing the applicant without headgear in a frontal view (biometric passport photograph)</li> <li>written statement about the loss</li> <li>the issuing authority may also require the holder of the driver card to make an affidavit stating that and for what reasons he/she is unable to return the driver card</li> </ul>
Voraussetzungen	<ul> <li>You have your residence in the Federal Republic of Germany.</li> <li>You hold a valid driver's license with one of the following classes: B, BE, C1, C1E, C, CE, D1, D1E, D, DE.</li> <li>Your valid driving license must correspond to one of the aforementioned classes if it was issued in an EEA member state.</li> </ul>

Kurztext	<ul> <li>Driver card replacement due to loss</li> <li>In case of loss of driver card, replacement card must be applied for</li> <li>bus drivers and truck drivers in commercial road</li> </ul>

	<ul> <li>traffic need a valid driver card</li> <li>from the time of loss, the person concerned may continue to drive without a valid driver card for a maximum of 15 days</li> <li>as long as the driver does not have a driver card, printouts from the digital tachograph must be made and carried on the vehicle</li> <li>Responsible: different authorities depending on the federal state, e.g. driving license authority, TÜV, Dekra or others.</li> </ul>
Ansprechpunkt	To apply for a driver's license, please contact the driver's licensing authority of the locally responsible district or city administration of the independent and large district towns; in the area of the large district towns of Bingen am Rhein and Ingelheim am Rhein, contact the Mainz-Bingen district administration.
