Teaser	If your workshop card is about to expire, you can apply for a new card at the relevant office.
Volltext	<ul> <li>The workshop card is a tachograph card for</li> <li>approved manufacturers of tachographs,</li> <li>vehicle manufacturers,</li> <li>workshops as well as</li> <li>their specialists such as installers or technicians.</li> </ul> Their responsible specialists use the workshop card to install, test, calibrate and download data from digital tachographs. It is valid for one year. If you want to renew your workshop card, you must apply for it as an entrepreneur or as an authorized representative or authorized person at the responsible office. For this purpose, you must submit a current certificate of recognition or commissioning of the workshop for testing tachographs. This must not be older than 3 years. For each application for renewal of a workshop card, you as the company must provide proof that the commissioned specialist is still employed by you and has been trained in accordance with the tachograph card and recording equipment training guidelines. The training certificate must not be older than 3 years. The workshop card is PIN-protected. The personal PIN number is sent to the employee's home address. Employees may only have one workshop card per
