Frist	The annual hunting licence shall be valid for a maximum of two consecutive hunting years. The hunting year starts on 01.04. and ends on 31.03.

Hinweise	• With a falconer hunting license, you may only hunt if accompanied by a custody with hunting experience or a supervised person with hunting experience commissioned in writing by your person(s) with custody. • With a falconry license, you are not allowed to participate in party hunts.
