Volltext	If you would like to hunt in Germany, but you are not yet 18 years old, you can only be issued with a youth falconry hunting licence in your name. If you are already in possession of an annual hunting certificate, but its validity has expired, you can apply for an extension.

Frist	The youth falconer hunting licence is valid for a maximum of two consecutive hunting years. A hunting year begins on 01.04. and ends on 31.03. of each year.

The accompanying person must be experienced in hunting. • The youth hunting license does not entitle you to participate in party hunts.
