Volltext	If you have taken over grapes, mash, grape must, grape must in fermentation or young wine from a wine-growing holding or other wine-making establishment, you must submit a list of suppliers for wine-making. You are obliged to report all additions and purchases. It is a pure message. You will not receive a notification from the authority afterwards.

Voraussetzungen	You have taken over (for example as a winery or trading company) wine products such as grapes, mash, grape must, partially fermented grape must or young wine for wine production or unchanged supply from a supplier (e.g. winegrower, winery).

access data and call up the supplier directory.

- The program will guide you step-by-step through the required information.
- Fill in the input fields online.
- At the end of the input masks, you can send the form directly online to the responsible office.

Alternatively, you can submit the report by post, fax, or e-mail.

- You can obtain the appropriate form from the competent authority.
- You fill out the form and submit it there by post or fax on time.

Alternatively, you can scan the form and send it by e-mail to the responsible office.

You must submit the list of suppliers for the wine production declaration by 15 January of the year following the harvest at the latest.

- Notification of supplier directory for wine production of products made from foreign products Acceptance
- Anyone who processes, uses, sells or dispenses wine products, such as wineries or (wine) merchants, is liable to pay the levy
 - from wineries or other establishments
 - for the manufacture of wine products, or
 - for unaltered supply (e.g. grapes, grape must)
- in the case of acceptance or take-over of grapes, mash, grape must, grape must in fermentation or young wine
- List of all suppliers
- Deadline: Until 15 January of the year following the harvest
