Volltext	If you would like to practice pickling in Germany, but you are not yet 18 years old, you can only be issued a youth falconer hunting licence in your name. If your German falconer's annual hunting licence for foreign young people has been revoked, you can apply for it again from the authority that revoked your hunting licence after the specified blocking period has expired.
