Teaser	If the validity of your day hunting licence for foreign youth falconers expires or has already expired and you wish to continue hunting, you must have it extended.
Volltext	If you would like to practice pickling in Germany, but you are not yet 18 years old, you can only be issued a youth falconer hunting licence in your name. If you are already in possession of a day hunting licence for foreign youth falconers, but its validity has expired, you can apply for an extension.

Kurztext	* Foreigner Youth Falconer Hunting Licence New issue of day hunting licence * required for pickling hunting in Germany * for persons who already have or have held a German hunting license * for persons under 18 years, minimum age 16 years * is valid for 14 consecutive days * Possession of an annual hunting license or foreigner's annual hunting license is a prerequisite * is issued by the authority that issued the hunting licence * responsible: lower hunting authority

Hinweise (Besonderheiten)	The youth hunting licence only entitles you to hunt accompanied by a person with custody or a supervisor commissioned in writing by the person with custody. The accompanying person must be experienced in hunting.





The youth hunting license does not entitle you to participate in group hunts.
