	As the farm manager, you must state your name and address or the name and address of your company. If several competent persons in your company are responsible for Ander plant protection products or act in an advisory capacity, you must state the names and addresses of all these persons. In addition, you must enclose proof of expertise in the use of plant protection products or advice on plant protection for all competent persons named in the notification.
	You must inform the competent authority immediately of any changes to the group of persons and those that affect the company details as well as the closure of the
